

### HISTORY

Canadian Religious Stewardship (CRS) was founded by Religious Institutes across Canada to assist Religious to reach their goals and needs.

CRS is a collaborative ministry and was granted the status of Public Juridic Person of Pontifical right by the Holv See on December 8. 2010. The associated civil corporation. **Canadian Catholic Congregational** Management, was established by the issuance of supplementary letters patent by the Minister of Industry of the Government of Canada on December 15, 2008, Canadian **Catholic Congregational** Management later had its name changed to Canadian Religious Stewardship by Industry Canada on June 9, 2015. This new name, the same as the PJP, was approved by the Canada Revenue Agency on March 7. 2016.



### PARTICIPATING ENTITIES

On February 24, 2006 Brother Michael Maher, FSC, Director of Canadian Religious Administrative Services (CRASI Inc.), brought together a small group of representatives from Canadian Religious institutes to Toronto, Ontario. The group explored ways to assist diminishing Religious institutes in the management of their finances, investments, properties, ministries, as well as leadership of their congregations and care of their members. The idea of an "umbrella" corporation emerged.

The meeting resulted in the commitment of leaders from ten congregations from across Canada, representing men and women, east and west, English and French, education and health care. For several months the group worked on developing statutes, by-laws, and on obtaining the support of the respective Bishops in order to petition CICLSAL and the Canadian government.

While the Federal government quickly approved the new CRS corporation (then named Canadian Catholic Congregational Management), the approval from CICLSAL required a three-year complex process. This was due in large part by the fact that Canadian Religious Stewardship was the first Public Juridic Person of its kind in the world!

The CRASI Board of Directors served as the Board of CRS. On September 27, 2012 the CRS Board was established. CRASI also provided important seed money for CRS as well as a loan, that CRS plans to honor in the next few years.

### ECCLESIASTICAL TEMPORAL GOODS


Ensured the management and safeguarding of ecclesiastical temporal goods and the administration in accordance with canon and civil law.

## STEWARDSHIP & SPONSORED ENTITIES



Canadian Religious Stewardship works with Religious Institutes who require one or more of the many services it has available. In response to the growing demand, and for the next phase of congregations coming to completion, CRS stewards Catholic apostolates through canonical sponsorship in agreement with diocesan and pontifical authorities.



## STEWARDSHIP & SPONSORED ENTITIES

In addition to working with Religious Institutes who request services, CRS is also the sole Member of four sponsored entities:

#### **Presentation Manor for Seniors**

Presentation Manor for Seniors is a notfor-profit corporation and CRS is its sole member and sponsor. The Presentation Manor Board of Directors is made up of four Religious and one lay person, including Sister Christine Gebel OLM who also serves on the CRS Board.



### Sisters of Saint Elizabeth of the Third Order Regular of Saint Francis of Assisi

The congregation of the Sisters of Saint Elizabeth of the Third Order Regular of Saint Francis of Assisi is a Public Juridic Person of Pontifical right. Upon request by the Sisters of Saint Elizabeth, followed by approval, CRS committed to sponsor the congregation. CRS has taken on the responsibility for the governance and care of the Sisters who now live in Trinity Manor and Samaritan Place, in Saskatoon, Saskatchewan. The most Reverend Donald Bolen, Archbishop of Regina and to whom the Holy See delegated the responsibility for appropriate decisions for this Religious Institute that would ordinarily be reserved to CICLSAL, has been kept apprised of the developments of the congregation by CRS. Only seven members remain as of May 31, 2020.

### Our Lady's Missionaries

Our Lady's Missionaries is a Religious congregation of women who devoted their lives to service by sharing with the poor and least privileged. The congregation was founded in Alexandria, Ontario in 1949. The first mission was opened in 1956 in Japan, followed the next year with a mission in Nigeria, and then to various countries including: Mexico, Philippines, Brazil, Guyana and many others. As at May 31, 2020 the remaining 21 Sisters live together in community with other Religious and lay persons at Presentation Manor for Seniors and at Providence Health Care in Toronto, Ontario.

In 2014, in response to requests from congregations, Canadian Religious Stewardship established the Foundation of Canadian Catholic Congregations (FCCC), a not for profit, charitable corporation under the Canada Not-for-Profit Corporations Act. 



### ANNUAL BOARD RETREAT JUNE 27, 2019

Father Francis Morrisey welcomed and introduced guest Dr. Anne Asselin Board Director, Catholic Health Sponsors Ontario who presented on the evolution and future Apostolate of the laity, sponsorship and the CHSO experience. Dr. Asselin referred to Vatican II and the rights and responsibilities of Laity beyond the walls of the church; Pope Francis and the concept of subsidiarity; encouraged the Board to think outside the box and take calculated risks; addressed the 3Ps -People, Property and Paper; spoke of sponsorship as a ministry; referred to the gift of dissent; and to finding our charism inspired by whom we work for. CRS Board Chair, Sr. Anne Lewans emphasized the importance of the Board of Directors commitment to formation.

### Canadian Religious Stewardship Commitment

The Canonical Statutes stipulate that Members of CRS shall satisfactorily complete initial formation and participate in a continuing formation program. In November 2011, the legal mandate of CRS for formation was delegated from the Participating Entities to its Board of Directors, at which time the Board committed to ensuring that ongoing formation would be at the heart of their Mission. The Board and the Executive Director were active in their formation.

## FIERA CRS ETHICAL INVESTMENT FUND

In direct response to requests from a number of Religious Institutes from across Canada, and for the need to give increased attention to ethical considerations Canadian Religious Stewardship established the Fiera CRS Ethical Fund.

Fiera Capital Corporation is an independent asset management firm, recognized for its work with Religious, and one of Canada's leading investment managers. Fiera offers the services of reputable investment managers to over one hundred religious groups. Its management fees are competitive and, in many cases, are less than the fees currently incurred by Religious Institutes.

Each participating Religious Institute holds its own proportionate share of the pooled fund and receives quarterly reports describing the status of their holdings including the results and the performance of their investment.

Fifteen Religious Institutes from across Canada have transferred the total, or a part of their investment portfolio to the Fiera CRS Ethical Fund.
